Instructions for the Payment of College Annual Tuition Fee :

b) Annual Tuition Fee: ₹35,000/- per year — to be paid online to the college.

- Only those students who consider their admission in Siddhartha Medical College as final (i.e., no up gradation in subsequent counselling rounds) are required to pay the Annual Tuition Fee through **online or UPI modes.**
